ARTICLE II: PURPOSE

To further the sport of model aviation

ARTICLE III: MEMBERSHIP

A. QUALIFICATIONS AMA membership required

B. DUES

Dues are:

1. Annual Membership dues are \$125.00 per year.
2. Annual membership dues payment is due by January 31st of each year.
 - a. All membership (new or returning) requests must be accompanied with a current completed CFSF membership application and dues payment.
 - b. Annual dues may be pro-rated at the discretion of club President and or Vice President based on date of NEW membership application.
 - c. Pro-Rated dues are applicable for current membership year only.
 - d. Current or returning memberships CANNOT be Pro-Rated.
 - e. New Member Pro-Rated Annual dues schedule is as follows and is based on initial membership application date.
 - a. January: \$125.00
 - b. February: \$115.00
 - c. March: \$100.00
 - d. April: \$90.00
 - e. May: \$80.00
 - f. June: \$70.00
 - g. July: \$60.00
 - h. August: \$50.00
 - i. September: \$40.00

- j. October: \$30.00
- k. November: \$20.00
- l. December: \$10.00

- 3. Youth Members \$50.00 per year
 - a. Must be less than 18 years of age.

C. RESIGNATION

Any member in good standing may resign his/her membership by giving written notice to the Club. Club dues are not refundable.

D. TERMINATION

If any member ceases to have the qualification necessary for membership in the AMA, his/her membership in the Club shall thereby terminate, subject to reinstatement upon restoration of eligibility at the officers' discretion.

E. EXPULSION

This section provides for enforcement of the Safety Rules that are related to flying activities or any other unacceptable behavior by an individual member or members. Any individual may be expelled from membership from the Club if in the officers' determination, such individual willfully commits any act or omission which is a violation of any of the terms of these Bylaws, or the Rules of the AMA, or which is detrimental to the Club, the AMA, or to model aviation.

F. REINSTATEMENT

The officers' approval is required for reinstatement to the club.

G. 90 DAY PROBATION

All new members serve a 90 day probation period, during which their membership may be terminated by the officers of the club. If terminated during the probation period any membership dues and/or Initiation Fee will be refunded.

B. TERM OF OFFICE

Annual. The incoming president is appointed by the out-going president.

C. DUTIES

- President shall preside at meetings and is responsible for day to day operations and administration of the club.
- VP shall preside in the absence of the president.
- Secretary/Treasurer maintains compliance with all AMA paperwork in addition to maintaining adequate books and records of the club's finances. (Note: This club member does not pay annual dues due to the extent of work required)
- Safety Officer shall enforce compliance with AMA safety requirements as it pertains to all flying activities.
- Field Marshal manages the maintenance of the flying field.

D. PRESIDENT APPOINTED OFFICERS

Vice-President, Secretary, Treasurer, Safety Officer, Field Marshal.

E. VACANCIES

Officer vacancies are to be filled by appointment of the president.

ARTICLE V: MEETINGS

Meetings will be called by the president on an as-needed basis.

D. MEMBERS' CODE OF CONDUCT

1. Any member who brings a guest pilot to the field is responsible to ensure that the guest is a member in good-standing with the AMA.

2. Any member who allows a non-member pilot to, in the view of the officers, become a "freeloader" in the club shall have their membership immediately terminated without a refund of dues at the officers' discretion.
3. Any member who, in the view of the officers, subjects other members at the field to harassment, verbal abuse, physical threat, or any other offensive behavior such as (but not limited to) incessant complaining about the club, its members, or its officers shall be subject to membership termination without a refund of dues.

E. DISSOLUTION OF CLUB

The duration of the club shall be perpetual. The club may be dissolved with the approval of two -thirds vote of the membership. In the event of dissolution, the club's assets net of liabilities will be donated to the AMA to further the sport of model aviation.

ARTICLE X: AMENDMENT OF THESE BYLAWS

A. PROPOSED:

Any member in good standing may propose an Amendment to the Bylaws

B. APPROVAL:

All Amendments to the Bylaws must be approved by the Officers of the Club.

C. VOTING:

All approved Amendments will be subject to a majority vote of the membership at a meeting called by the President of the club.

ARTICLE XI: GRIEVANCE PROCEDURE (FLIGHT AND SAFETY RULES)

The club's officers reserve the right to immediately terminate, without refund, any member's membership due to unsafe, thoughtless, or any activity which jeopardizes the club's sanction with the AMA or the general population's safety. At least one witness is required.
